Official release of the documents regarding Mohamed Mahdi's and his coconspirators illegal activities



THE MOHAMED MAHDI FILES

The Republic of Keegan (KLW) reaffirms its longstanding commitment to transparency between the government and its citizens-an assurance upheld since the publication of our fiscal reports in 2024, prior to their suspension following the February 11th attacks.

After a thorough internal review, the Government has confirmed evidence linking High-Ranking Government Lawyer **Mohamed Mahdi** to activities that fall short of the ethical standards expected from public office and from those who serve the people of Keegan. These findings are serious, raising important questions about accountability and integrity within our institutions.

In keeping with our commitment to transparency, the Government is releasing the full investigative files on Mr. Mahdi. These documents will be made publicly available so that citizens may see the facts directly, without interpretation or concealment. By doing so, we aim to eliminate any doubts about favoritism or the suppression of truth.

At this time, Mr. Mahdi will not face arrest, suspension, or disbarment. The Government has determined that making the evidence available to the public is the most responsible step forward. We believe accountability is best served by openness rather than by action taken behind closed doors. That said, this decision does not shield Mr. Mahdi from further scrutiny. Should new evidence come to light, or should the people demand stronger measures, this matter may be revisited.

The Republic of Keegan remains firm in its belief that no one-regardless of their position-is beyond the oversight of the people they serve. By releasing these files, we reaffirm our promise to act with honesty, transparency, and respect for the trust that binds the government to its citizens.



1. Overview Regarding Mr. Mahdi's Activities

The Government of the Republic of Keegan (KLW), following a comprehensive internal investigation, has identified a series of serious allegations against High-Ranking Government Lawyer **Mohamed Mahdi**. These charges constitute substantial breaches of law, ethics, and public trust, with potential implications for national security and the integrity of the state.

Mr. Mahdi is formally accused of:

- Treason against the Republic of Keegan (KLW)
- Conspiracy to commit treason with other officials, domestic and foreign
- Conspiracy to commit murder in the first, second, and third degree
- Bribery and corruption in office
- Fraud and misappropriation of public resources
- Identity fraud and falsification of official records
- Insider trading and stock market manipulation

Mr. Mahdi is also believed to have acted in concert with a number of individuals who either were aware of, or actively participated in, the alleged illegal activities. A complete list of these alleged co-conspirators is provided later in this document under Figure 1.

These allegations are supported by documentary evidence, official records, and corroborating statements obtained during the inquiry. While all proceedings remain subject to due process, the gravity and breadth of these offenses necessitate full disclosure to the public.



2. Mohamed Mahdi's Client List

As part of the investigative release, the Government is publishing the complete client list associated with Mr. Mahdi's professional activities. This step is taken in the spirit of transparency, ensuring that citizens have access to the same records reviewed during the inquiry.

It is important to emphasize that inclusion on this list does **not** imply direct involvement in, or knowledge of, the illegal activities under examination. The list is provided solely as part of the official documentation, offering a full account of Mr. Mahdi's professional and extralegal associations during the period under review.

Citizens should also note that certain names or details appearing as redacted within the list were withheld **by**Mr. Mahdi himself prior to the seizure of the document. The Republic of Keegan has not altered, censored, or modified the content in any way. What is presented here is an exact reproduction of the files as they were obtained, ensuring full accuracy and authenticity.

Engaging in business or professional dealings with any individuals listed in the co-conspirator records is strongly discouraged due to the ongoing investigation. Association with these individuals may carry legal and reputational risk, and caution is advised to avoid involvement in potential misconduct.

For clarity and ease of reference, the client list is displayed in two forms: on the **left**, an image of the original document as recovered from the investigative files, and on the **right**, a printed transcription of the same information. This format preserves the integrity of the original while also making the contents accessible in a clear, legible form.

2.1 Noteworthy Individuals

The Republic of Keegan has classified the individuals identified in the investigation into three categories:

- Confirmed Co-Conspirator individuals alleged to have actively participated in the illegal activities. It is highly recommended to not preform business with an induvial classified as such.
- **Aware Non-Participant** individuals alleged to have been aware of the activities but did not participate or report them. Precaution is required with preforming business with an individual classified as such.
- Unaffiliated / Uninformed individuals for whom there is no evidence of knowledge or involvement in
 the activities. Little precaution is required with preforming business with an individual classified as
 such.

It should be noted that all information in this report remains **alleged**; however, for clarity and readability, the term "alleged" will not always be repeated throughout the document.

The KLW has compiled a classification of the individuals named in this investigation as a service to the public, with the intention of providing clear guidance on the level of caution that should be exercised when engaging with them. This classification is not intended to condemn without due process, but rather to inform citizens of the risks associated with professional, financial, or social dealings while inquiries remain ongoing.

By setting out these categories, the Government seeks to equip the public with the knowledge necessary to make informed decisions, and to ensure that citizens are not unknowingly drawn into situations that may compromise their legal or personal standing.





The official KLW list is provided below, accompanied by explanatory notes where available, to clarify the nature of each individual's alleged association with the matters under investigation.

The individuals mentioned in the list that are not unaffiliated / uninformed should once again be approached and interacted with in caution.



2.2 Mohamed Mahdi and Nathaniel Munchov

Nathaniel Munchov, publicly known by his stage name Sir NutMuncher, immigrated to the Republic of Keegan under the legal oversight of High-Ranking Government Lawyer Mohamed Mahdi. According to the submitted documentation, his declared identity upon entry was "Nathaniel Munchov."

Subsequent review of immigration records has revealed significant irregularities. Critical documentation typically required for processing is either incomplete or altogether absent. This absence of verifiable records has raised strong suspicions regarding the authenticity of Mr. Munchov's declared identity.

The KLW does not believe this matter to be an act of goodwill on the part of Mohamed Mahdi, such as leniency toward an immigrant lacking proper documentation. On the contrary, available evidence indicates that Mahdi knowingly concealed these irregularities. For reasons that cannot be disclosed at this time, it is further believed that Mr. Munchov bribed Mahdi with a significant sum of money in exchange for facilitating the falsification of his identity and enabling his entry into the Republic.

The motive behind Munchov's desire to obscure his true identity remains unclear. Investigators continue to pursue this matter in order to determine whether this action was undertaken for personal, financial, or political reasons, or as part of a larger conspiracy.

2.3 Mohamed Mahdi and the Lahoma Family

The investigation has identified a longstanding relationship between High-Ranking Government Lawyer Mohamed Mahdi and members of the Lahoma family, most notably Robert J. Lahoma and Oak J. Lahoma. Evidence indicates that Mahdi was directly involved in concealing and facilitating a range of illegal commercial operations undertaken by the Lahomas.



With respect to Robert J. Lahoma, Mahdi assisted in disguising the sale of counterfeit and bootleg footwear, ensuring the products appeared legitimate and shielding the enterprise from exposure. Rather than pursuing lawful enforcement, Mahdi actively contributed to the fraudulent presentation of Robert's business operations.

In the case of Oak J. Lahoma, investigators uncovered Mahdi's role in supporting and advancing a number of unlawful market practices. These included insider trading, stock manipulation schemes designed to inflate the value of RFL (Robert's Foot Locker), and direct involvement in acts of corporate espionage. Evidence shows that Mahdi not only advised Oak on these practices but also coerced and blackmailed high-ranking officials within competitor businesses in order to secure confidential information and undermine rival companies.

The relationship between Mahdi and the Lahoma family was sustained by a clear financial arrangement. Records indicate that Mahdi received 15% of all profits earned illegally through these schemes, establishing an ongoing exchange of protection and support for material gain.

The scope of this partnership demonstrates a deliberate and organized pattern of collusion between Mahdi and the Lahoma family, representing a profound breach of both legal duty and public trust.

2.4 Mohamed Mahdi and Tshering Tobgay

Tshering Tobgay (spelled Tshong Tobay in Mr. Mahdi's client list) is the current Prime Minister of Bhutan. The investigation has established that Mahdi maintained direct dealings with Tobgay and played a pivotal role in shaping events that culminated in the Keeganian–Bhutanese War.

According to testimony and corroborating evidence, Mahdi actively facilitated the rigging of a high-stakes gamble between Prime Minister Tobgay and General Nicklas Hooton of the Republic of Keegan. The wager, conducted during an international conference, placed the Keeganian state of Jayselahoma and \$7 USD



against the entire territory of Bhutan, excluding its capital. Through Mahdi's intervention, Tobgay secured victory in the gamble, resulting in the official cession of Jayselahoma to Bhutanese control.

This event served as the direct catalyst for the escalation of hostilities. Following Bhutan's acquisition of Jayselahoma, Tobgay declared war on the Republic of Keegan and initiated military operations in the region.

The resulting conflict-lasting forty minutes-saw Bhutanese forces occupy Dylidaho temporarily before being repelled by Keeganian counteroffensives, including the deployment of the experimental KeegBot II. While Keeganian forces successfully regained Dylidaho, Bhutan retained Jayselahoma as its territory at the conclusion of hostilities.

The evidence strongly suggests that Mahdi's manipulation of the gamble was not an isolated act of misconduct, but a deliberate intervention with profound geopolitical consequences. By ensuring Tobgay's victory, Mahdi directly contributed to the destabilization of regional security, the outbreak of armed conflict, and the loss of Keeganian territory.

The motives behind Mahdi's assistance to Tobgay remain under review. Investigators are examining whether the arrangement was the result of financial bribery, political collusion, or other undisclosed agreements between the two parties.

2.5 Aware Non-Affiliates and Non-Participants

The KLW does not consider it necessary to dedicate a formal section to individuals categorized as Aware Non-Affiliates or Non-Participants. Their connections to Mr. Mahdi are deemed peripheral, mundane, and without material impact on the matters under investigation. Accordingly, their inclusion in the client list is acknowledged, but no further elaboration is warranted.



3. Conclusion

The Government of the Republic of Keegan (KLW) has conducted an extensive review of the activities of High-Ranking Government Lawyer Mohamed Mahdi. The allegations detailed in this report-including his purported facilitation of illegal operations, manipulation of international affairs, and involvement in actions contributing to the Keeganian–Bhutanese conflict-indicate that Mr. Mahdi poses a significant risk to legal, financial, and public institutional integrity.

It must be emphasized that all information contained herein remains alleged; no determination of guilt has been made. While Mr. Mahdi has not been arrested or formally sanctioned at this time, the Government strongly advises that interactions with him, whether professional or social, be undertaken with extreme caution. Citizens and institutions should be aware that his conduct, as currently documented, reflects a pattern of untrustworthiness and potential for serious misconduct. Engagement with Mr. Mahdi should be limited to circumstances deemed strictly necessary, and with full awareness of the associated risks.

The Republic of Keegan affirms its commitment to pursuing these matters to the fullest extent permitted by law. Should additional evidence arise, or should the will of the people demand stronger measures, the Government will act decisively to ensure accountability and uphold the integrity of public office.

The Republic of Keegan remains committed to upholding the principles of honesty, transparency, and integrity in governance. By publishing these findings, the Government affirms its dedication to maintaining the trust of its citizens while continuing to investigate all matters fully and impartially.
